PUBLIC NOTICE OF DISAPPROVAL OF REGISTRATION APPLICATION

In re Registration Application of Price & Gartrell, P.C.

PCAOB Release No. 102-2010-002 March 1, 2010

The Public Company Accounting Oversight Board ("the Board") has disapproved the registration application of Price & Gartrell, P.C. ("Price"), 8465 Keystone Crossing, Suite 195, Indianapolis, Indiana 46240. Pursuant to section 105(d)(1)(C) of the Sarbanes-Oxley Act of 2002 ("the Act") the Board hereby makes public the disapproval determination and the basis for that determination.

The grounds supporting the Board's disapproval determination are described in the Notice of Hearing attached as an appendix to this release, which the Board issued to Price on December 3, 2009, pursuant to PCAOB Rule 2106(b)(2)(ii). By its terms, the Notice of Hearing became the Board's written notice of disapproval, effective as of December 3, 2009, when Price failed to request a hearing by December 17, 2009. Because Price failed to seek Securities and Exchange Commission review of the Board's determination within the period specified by the Commission's rules, the stay described in section 105(e) of the Act does not operate to delay public notice of the disapproval.

Background

- 1. The Public Company Accounting Oversight Board ("the Board") has received an application for registration with the Board from Price & Gartrell, P.C. ("Price").
- 2. Section 102(c)(1) of the Sarbanes-Oxley Act of 2002 ("the Act") provides that the Board shall

approve a completed application for registration not later than 45 days after the date of receipt of the application, in accordance with the rules of the Board, unless the Board, prior to such date, issues a written notice of disapproval to, or requests more information from, the prospective registrant.

Pursuant to the Act, the Board has adopted rules ("PCAOB Rules") related to the registration process, and the Securities and Exchange Commission ("the Commission") has approved those rules.

- 3. Under PCAOB Rule 2102, the date of receipt of Price's application was October 21, 2009.
- 4. The Board's rules provide that the Board will, with respect to an application,

determine whether approval of the application for registration is consistent with the Board's responsibilities under the Act to protect the interests of investors and to further the public interest in the preparation of informative, accurate, and independent audit reports for companies the securities of which are sold to, and held by and for, public investors.

5. If, after reviewing the application, the Board is unable to make the determination described in paragraph 4 above within 45 days of receipt of the application, the Board may request additional information from the applicant or the Board may provide the applicant with a written notice of a hearing to determine whether to approve or disapprove the application. PCAOB Rule 2106(b)(2).

Notice of Hearing Procedure

- 6. Pursuant to PCAOB Rule 2106(b)(2)(ii), the Board has determined to provide Price an opportunity for a hearing under PCAOB Rule 5500 to determine whether to approve or disapprove Price's application for registration. Under the Act and those Board rules, Price has the following two options with respect to this notice
 - a. Price may elect to have a hearing before a Board hearing officer pursuant to the Board's rules; or
 - b. Price may decline to have a hearing and may instead elect to treat this notice as a written notice of disapproval of Price's application for purposes of Section 102(c) of the Act.
- 7. If Price elects a hearing
 - a. Price will be deemed to have waived any right to have a Board determination on its application within the time period provided in Section 102(c)(1) of the Act;
 - b. the Board shall appoint a hearing officer to hear evidence concerning the proposed grounds for disapproval described in paragraph 13 below, to hear other relevant evidence offered by Price or the Board staff, and to prepare an initial decision. PCAOB Rules 5200(b), 5204(b); and
 - c. the Board's Secretary shall serve the parties with a Notice of Assignment of Hearing Officer, the date of which shall constitute the date of the institution and commencement of the proceeding.
- 8. To elect a hearing, Price must, on or before December 17, 2009, file with the Board's Secretary a written request for a hearing date and a notice of appearance. PCAOB Rules 5500, 5401(c). Price must include with the request –

- a. a statement that Price has elected not to treat this notice as a written notice of disapproval for purposes of Section 102(c) of the Act; and
- b. a statement describing with specificity why Price believes that the Board should not issue a written notice of disapproval.
- 9. If Price elects to forego a hearing and instead chooses to treat this notice as a notice of disapproval for purposes of Section 102(c) of the Act, Price should notify the Board's Secretary of its election by December 17, 2009.
- 10. If Price fails to take the steps described in paragraph 8 above and fails to take the step described in paragraph 9 above, Price will be deemed to have elected to treat this notice as a notice of disapproval for purposes of Section 102(c) of the Act.
- 11. If this notice is treated as a notice of disapproval, whether by Price's election or by Price's failure to make an election by December 17, 2009
 - a. the date of this notice shall constitute the date of the Board's disapproval, and the proposed grounds described in paragraph 13 below shall constitute the final grounds of the Board's disapproval;
 - b. as provided by Section 102(c)(2) of the Act, this notice of disapproval shall be treated as a disciplinary sanction for purposes of sections 105(d) and 107(c) of the Act;
 - c. as provided by Section 105(d) of the Act, the Board shall report this sanction to
 - (1) the Commission;
 - (2) any appropriate state regulatory authority or any foreign accountancy licensing board with which Price is licensed or certified; and
 - (3) the public (once any stay on the imposition of such sanction has been lifted); and
 - d. as provided by Section 107(c) of the Act, Price may, in accordance with the Commission's rules governing time limitations and procedural matters, petition the Commission to review the disapproval determination.

Basis of Disapproval

- 12. The Board has considered the following information, which includes information obtained by the Board in connection with Price's application as well as the requirements of the Act and the Board's rules
 - a. On or about August 17, 2009, Price certified the financial statements, including the balance sheet and income statement, of Indiana Merchant Banking & Brokerage Company, Inc. ("Merchant"), a registered broker-dealer, for the fiscal year ended June 30, 2009, which Merchant subsequently filed with the Commission.
 - b. Section 17(e) of the Securities Exchange Act of 1934, required that the balance sheet and income statement filed with the Commission by Merchant for the fiscal year ended June 30, 2009 be certified by a registered public accounting firm.
 - c. On the date that Price certified the Merchant balance sheet and income statement for the fiscal year ended June 30, 2009, Price was not a registered public accounting firm.
 - d. Although Price's conduct with respect to Merchant's financial statements did not involve, and the Board is unaware of conduct by Price involving, the audit of any "issuer" (as defined in the Act and the Board's Rules), approval of Price's registration application would make it lawful for Price to provide audit reports for issuers.
- 13. As provided in PCAOB Rules 2106(b)(2)(ii) and 5201(c), and on the basis of the information described in paragraph 12, the Board identifies the following proposed grounds for disapproving Price's registration application
 - a. Price certified the balance sheet and income statement of a registered broker-dealer, for filing with the Commission, for a period with respect to which Price knew or should have known that those financial statements were required by law to be certified by a registered public accounting firm.
 - b. Price's certification of these financial statements while not registered with the Board appears to demonstrate an unwillingness or inability to exercise sufficient care with respect to relevant legal requirements.
